I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 27/07/2017 considered the Compliance Verification Assessment Report (04/10/2016) along with the Council Assessor's Report (May, 2015 & 21.03.2016) on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification for 02 seats at Muzaffarnagar Medical College, Muzaffarnagar granted by Ch. Charan Singh University and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/10/2016) along with the Council Assessor's Report (May, 2015 & 21.03.2016) and decided to recommend to the Central Government that MD(General Medicine) qualification for 02 seats granted by Ch. Charan Singh University in respect of students being trained at Muzaffarnagar Medical College, Muzaffarnagar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
