## IMPORTANT INFORMATIONS

### Fee

1. Hostel fee includes mess charges and Hostel rooms are air-conditioned with Wi-fi facility. There shall be 5% increment in Hostel fee per year.
2. Fee is payable by demand draft payable at New Delhi in favour of Muzaffarnagar Medical College or fees can be transferred to our account through RTGS favouring of Muzaffarnagar Medical College, **Account No. – 20395006092 (Current Account), IFSC Code – ALLA0212004, Bank Name – Allahabad Bank, Branch – AnandVihar, New Delhi.** No Cash will be accepted.
3. PAN Card is mandatory for paying fee by any mode of payment.
4. The fees to be deposited every year by 30<sup>th</sup> May in advance for the coming academic year. A fine of Rs. 500 per day will be charged after 30<sup>th</sup> May. Any student whose fee along with the fine imposed on him/her for delayed submission is found to be unpaid will be suspended from attending lecture/practical classes.
5. In accordance with the judgement passed by Hon'ble Supreme Court in Islamic Academy of Education Vs State of Karnataka 2003 (6) SCC 722, the managements of the institution may seek Bank Guarantee for tuition fees for whole Course. The candidate may also deposit full advance fee, which shall be kept in the form of FDR in a nationalized Bank. At the end of the course the interest earned on these deposits shall be paid to the candidate.

### Refund

1. Security Deposit is refundable only after the completion of the programme.
2. **In the case of withdrawal after admission no fee is refundable in any case.**
3. The Security deposit if no claimed within 02 years of the completion of the programme shall be deemed to be notated to the college fund.

### Stipend

1. Stipend will be paid per month as per norms applicable in the State.
