Subject: Ch. Charan Singh University - Recognition of MS(OBG) qualification for 2 seats in respect of students being trained at Muzaffarnagar Medical College, Muzaffarnagar.

Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 09.01.2018 considered the Compliance Verification Assessment Report (24/11/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 27/01/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification for 2 seats at Muzaffarnagar Medical College, Muzaffarnagar granted by Ch. Charan Singh University. The Committee decided as under:-

*"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (24/11/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 27/01/2017 submitted by the college authorities and decided to recommend to the Central Government that MS(OBG) qualification for 2 seats granted by Ch. Charan Singh University in respect of students being trained at Muzaffarnagar Medical College, Muzaffarnagar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.*

*The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

You are therefore requested to notify the above qualification at the earliest.
